Answer 3: This will be special condition since it falls outside of the 7:00 a.m. to 6:00 p.m. working hours. The consultant will work with the Roads and Drainage Division to coordinate the lane closures outside of the set times. The decision will be ultimately be made by the Roads and Drainage Division.

Question 4: Is there a required percentage of minority owned businesses that must be subcontracted for this project?
