The following clarifications/changes are issued as an addendum:

Words struck through are deleted; Words underlined are added.

#### **BidSync Question 15**

Can you please modify the Supplemental Qualifications to include following projects:

1) One filter project over \$ 500,000.

2) Allow filter projects to have either steel or concrete tanks.

3) Allow (1) of the projects to be a Wastewater Upflow Filter Project to meet the requirements, as the grouting requirements (of the cones) and number of components in each filter is significantly more complicated than standard sand and anthracite filters.

4) Allow (1) of the Projects to include existing Filters "Including under-drains and/or surfaces washes and/or air scour systems"

In response to Question 15, the following change has been made provided below.

#### Change 1. Specifications Change – Section 01 11 00, Paragraph 1.07.A

A. Minimum qualification requirements for General Contractors shall include completion of at least 3 projects in the past ten (10) years, which meet the following criteria:

- 1. Minimum contract value of \$1,000,000.
- 2. Water or wastewater treatment plant projects. The scope of work for these reference projects shall include either water and/or wastewater filters (including underdrain and surface wash assemblies) in reinforced concrete water retaining structures of at the least the size indicated on the drawings. Contractor project manager and superintendent shall have directly performed filter media replacement projects at a water and/or wastewater facility within the last 8 years.
- 3. Retrofit, rehabilitation, or improvements completed to an operating water or wastewater facility without unreasonable disruptions to service due to Contractor's actions or failure to act.
- 4. Work including water retaining structures, gravity piping systems, site work, structural repair, mechanical, and work of similar type, size, and complexity.
- 5. Projects completed and operating to the satisfaction of County (to be verified by calling references).

6. Projects completed on time.

7. Projects completed within budget without unreasonable claims or excessive change orders. B. Any sub-contractors selected by Contractor shall have equivalent experience for the trade in which the work will be performed (exclusive of dollar value noted).

A. Minimum qualification requirements for General Contractors shall include completion of at least 1 project in the past twelve (12) years, which meet the following criteria:

- 1. Minimum contract value of \$500,000.
- 2. Water or wastewater treatment plant projects. The scope of work for these reference projects shall include either water and/or wastewater filters (including underdrains, and/or surface wash assemblies, and/or air scour systems) in reinforced concrete or steel water retaining structures of at the least the size indicated on the drawings. Contractor's project manager and/or superintendent shall have directly performed filter media replacement projects at a water and/or wastewater facility within the last 12 years.
- 3. <u>Retrofit, rehabilitation, or improvements completed to an operating water or wastewater facility</u> without unreasonable disruptions to service due to Contractor's actions or failure to act.
- 4. Work including water retaining structures, gravity piping systems, site work, structural repair, mechanical, and work of similar type, size, and complexity.
- 5. <u>Projects completed and operating to the satisfaction of County (to be verified by calling references).</u>
- 6. Projects completed on time.
- 7. Projects completed within budget without unreasonable claims or excessive change orders.
