

INVITATION TO BID

Sealed Bids shall be received at the office of Bonita Springs Utilities, Inc. (BSU), Bonita Springs, Florida until **2:00 PM, Monday, March 30, 2020**, for the **Water Main Improvement Maddox Lane** project. The work to be performed consists of the following:

1. The work includes relocating and adjusting utilities owned by BSU to accommodate sidewalk improvements proposed by the City of Bonita Springs. This project includes installation of 1,451 LF of 10" C900 DR18 PVC water main; 14 LF of 8" C900 DR18 PVC water main, 47 LF of 4" C900 DR18 PVC water main, 261 LF of 2" Polytube C901 DR9, and 129 LF of 2" Polytube (Fire Line), 3 connections to existing 10" PVC main, 5 connections to 8" PVC main and 1 connection to 4" fire line.
2. Abandonment of approximately 682 LF of 8" PVC water main, 1,503 LF of 6" PVC water main, 239 LF of 2" PVC water main.
3. Restoration and miscellaneous work.

All work shall be in accordance with BSU Standard Specifications, latest edition.

No bid received after the time and date stated will be considered. General conditions shall be in accordance with Engineer's Joint Documents committee of NSPE, ASCE, ACEC, and CSI; a copy of which is included.

The successful Bidder shall furnish a Performance and Guarantee Labor, Subcontractor and Material Payment Bond in the amount of one hundred percent (100%) of the Base Bid at time of execution of the Contract. Contractor shall furnish Certificate of Insurance in the aggregate amounts listed in the Supplementary Conditions and Special Provisions. BSU shall be named as additional insured.

The Performance Bond and Payment Bond shall be obtained from an agency or a Surety or Insurance Company, which shall have an establishment or place of business in the State of Florida, shall be duly licensed to conduct business therein, and shall be acceptable to the OWNER. A five percent (5%) Bid Bond is required.

All work shall be completed in accordance with the contract documents including the provided Plans and Specifications. Digital copies of the BSU Standard Professional Services Contract, General Conditions, Standard Agreement, and Supplemental Technical Specifications are included.

The successful Bidder shall abide by all terms and conditions of the existing permits including: FDEP Environmental Resource Permit and Florida Department of Health potable water permit. Digital copies of the permits are available upon request. Any permit modifications shall be at the contractor's expense. Contractor shall obtain all other necessary permits required for construction including ROW permits, etc. Please contact msd@johnsoneng.com for digital copies of the above documentation and permits.

Bids shall be submitted in duplicate on Bid Forms furnished, with the exception of the Schedule of Values. An Excel spreadsheet has been provided to enter values. Only enter specific unit costs for each project area on each of the tabs. Do not enter values on the Totals tab or in the Total column; formulas have been input to auto-calculate these values based upon the input unit costs. Submit the completed Schedule of Values on CD with the Bid. Bids shall be submitted in sealed envelopes addressed to:
