SCOPE OF WORK

Remove existing flat roof of building 848 roof and replace as follows:

- Supply and install (2 inch ISO Board) insulation system fastening with OlyBond Spot Shot.
- Supply and install one ply of (Certain Teed Ultra Glass Self-Adhered) base sheet.
- All wall flashing will be inspected and cleaned.
- Supply and install new #180 white granulated torch down system.
- Supply and install new 26-gauge metal eave drip to match existing.
- Supply and install termination bar where/if needed.
- Supply and install new pipe boots and galv. hoods to all standard protrusions.
- Flash all details according to manufacturer's specifications
- Remove job related debris and clean up job site daily.
- All dumping and permit fees included.

5 Year Jones Warranty on Workmanship and Leakage

Note: Supply and install up to four sheets of plywood decking (M&L) included in above price. (\$64.00 per sheet material and labor for additional decking). Carpentry repairs to any trusses, fascia, and/or soffit to be at an additional \$50.00 per hour, per man, plus cost of materials. Any damaged wall flashing will be replaced with additional labor plus materials as needed. Any additional unforeseen price increases (material delivery, loading on roof, material increase, etc.) will be on final invoice. Terms are not transferable. We are not responsible for damage to underside of roof decking including plumbing, electrical, etc. We are not responsible for driveway damage due to settling fill or undermined conditions. We are not responsible for Satellite dishes on roof. We will re-install the satellite dish and do our best to position it like it was before reroof.

Note: We are fully licensed and insured. All past due sums will be 1.5% per month in the event this account is referred to an attorney for collection and the customer shall be responsible for all court costs and attorney fees.
